SUBJECT: Laboratory Issue Memorandum for the Ford Livonia Transmission Plant
Off-site Samples Received April 16, 2019

The Department of Environment, Great Lakes & Energy (EGLE), Remediation and Redevelopment Division has reviewed the "Memorandum Regarding Laboratory Issues Affecting Select Off-site Samples" (Memorandum) received April 16, 2019. This Memorandum describes laboratory issues from the Eurofins laboratory that affected the indoor air sample canisters from six residences and two commercial businesses. The Memorandum included a narrative describing the cause of the contaminated indoor air sample canisters and Memos from Eurofins stating the canisters were contaminated.

The Memorandum describes on April 3, 2019, Eurofins contacted Arcadis and asked seven indoor air samples canisters be returned. No documentation of this was provided in the Memorandum except for the description. Documentation from Eurofins should be provided to EGLE for review for these seven indoor air sample canisters.

The dates for re-sampling of the residences was provided except for re-sampling at 12141 Boston Post and 11721 Boston Post. The date for re-sampling of these homes should be provided to EGLE by May 15, 2019. Provide verification that the re-sampling scheduled for April 15, 2019 through April 17, 2019, and April 22, 2019, was conducted.

It was stated that re-sampling of the commercial businesses would not be conducted due to "ample coverage of the building" from the other indoor air canisters at the businesses. EGLE will review sample results and locations when submitted and determine if these locations should be re-sampled or if we concur.
