On behalf of Ford Motor Company (Ford), this memorandum has been prepared by Arcadis of Michigan, LLC for the Livonia Transmission Plant (LTP) site (the site). On May 3, 2019 the Michigan Department of Environment, Great Lakes & Energy (EGLE), Remediation and Redevelopment Division provided comments and questions regarding the memorandum submitted by Ford on April 16, 2019 detailing laboratory issues.

<u>Comment 1</u>: The Memorandum describes on April 3, 2019, Eurofins contacted Arcadis and asked seven indoor air samples canisters be returned. No documentation of this was provided in the Memorandum except for the description. Documentation from Eurofins should be provided to EGLE for review for these seven indoor air sample canisters.

<u>Response 1</u>: The attached memorandum from Eurofins Air Toxics provides the requested documentation. In addition to the seven samples discussed in the April 16, 2019 memo, Eurofins also asked for O0308/6L0703 to be returned making a total of eight recalled canisters. This eighth canister (O0308/6L0703) was also sent back to the laboratory unused.

<u>Comment 2:</u> The dates for re-sampling of the residences was provided except for re-sampling at 12141 Boston Post and 11721 Boston Post. The date for re-sampling of these homes should be provided to

EGLE by May 15, 2019. Provide verification that the re-sampling scheduled for April 15, 2019 through April 17, 2019, and April 22, 2019, was conducted.

<u>Response 1</u>: The dates of completed, or scheduled, resampling at each residential property are provided below. Data will be provided to EGLE as it becomes available. As indicated below a mitigation system was installed at 12141 Boston Post between the time of original sampling (February 26, 2019) and resampling. No other mitigation systems have been installed in this timeframe for the properties listed below.

- 12141 Boston Post Resampling is scheduled for May 20-22, 2019, representing post-mitigation conditions.
- 11721 Boston Post Resampling occurred May 1-2, 2019
- 11710 Boston Post Resampling occurred as scheduled on April 23-24, 2019
- 34669 Beacon Resampling occurred as scheduled April 16-17, 2019
- 12124 Boston post Resampling occurred April 16-17, 2019

As described in the April 18, 2019 memorandum, Eurofins Air Toxics evaluated histories of all the canisters currently in the field as of April 2,2019 and a list of suspect canisters was provided to Arcadis between April 2, 2019 & April 3, 2019 to recall prior to their use for sample collection. Additionally, canisters provided by our sister labs were recalled because canister histories were not readily available. The canister IDs are as follows:
