The Department of Environment, Great Lakes, and Energy (EGLE), Remediation and Redevelopment Division, has reviewed the "Response Activity Plan – Utility Corridor Evaluation Revised" (ResAP) received by EGLE on February 11, 2020, as required under Section 6.7(a)(v) of the Consent Decree, No. 2:1712372-GAD-RSW. The ResAP describes the remedial investigations Ford Motor Company (Ford) is proposing to undertake both on-site and off-site related to the utility corridors at the Area of Concern. Due to the added detail and inclusion of all information necessary to address deficiencies in Ford's previous plans, EGLE has determined Ford's February 2020 ResAP is approved.

EGLE's approval of the submission (ResAP) is based upon the representations and information contained in the submittal, therefore EGLE expresses no opinion as to whether other conditions that may exist will be adequately addressed by the proposed response activities. Notwithstanding this approval, if environmental contamination is found to exist that is not addressed by the ResAP and Ford is otherwise liable for the contamination, additional response activities may be necessary.
