SUBJECT: Monthly Updates on Offsite Mitigation Systems related to the Ford Livonia Transmission Plant, 36200 Plymouth Road, Wayne County, Michigan
EGLE Site ID No.: 82002970

The Department of Environment, Great Lakes, and Energy (EGLE), Remediation and Redevelopment Division has reviewed Memorandums submitted by Arcadis on behalf of Ford Motor Company (Ford) dated May 24, 2019, June 7, 2019, and July 12, 2019, regarding Mitigation Systems in the adjacent Alden Village Subdivision. Staff of EGLE have reviewed these Memorandum and have the following comments and questions:

- Mitigation systems at 12100 Boston Post, 12141 Boston Post, 12066 Boston Post, 34682 Beacon, 34480 Capitol, and 34591 Beacon were reported to not be obtaining performance metrics. Specific dates that the systems will meet performance metrics are required and should be achieved on an expedited basis.
- Homes where garages/additions have been converted to living spaces must meet performance metrics currently and not at an unspecified future date.
- Updates were provided for many homes where mitigation system installations were underway or scheduled to be installed. Estimated completion dates should be provided for these residences in addition to the other information provided. Dates for installation were not provided for 12070 Boston Post, 34682 Beacon, 34591 Beacon, and 34367 Capitol. Dates should be provided for these residences for installation and estimated completion dates.
- The mitigation system at 12089 Boston Post was reported in the past to have water within the mitigation system. This should be thoroughly evaluated and adjustments to the system should be made to ensure water does not enter the system. A report on any adjustments made should be provided in the August Monthly Update.

- Homes at 12121 Boston Post, 12124 Boston Post, and 34644 Beacon are not providing access according to the Memorandums. Please provide details and estimated dates of the next steps Ford will take for interim preemptive mitigation at these properties to EGLE, by July 31, 2019.
- The July 12, 2019 Update did not include 12034 Brewster, please provide an update on this residence to EGLE by July 31, 2019.
