The Department of Environment, Great Lakes, and Energy (EGLE), Remediation and Redevelopment Division has reviewed the "Utility Corridor Evaluation Revised – Addendum" submitted by Arcadis of Michigan, on December 4, 2020. Section 13.2 of the Consent Decree requires EGLE to review the submission and (a) approve the submission; (b) approve the submission with modifications; or (c) disapprove the submission and notify the Defendant of the deficiencies in the submission."

Based on EGLE review of the proposed additions to the scope of work, the submittal is approved with the following modifications:

- Ford will develop an interim remedial action plan for the LTP concurrently with workplan implementation.
 - The interim remedial action plan will investigate and evaluate all receptors that the utility corridors impact, where soil-gas is above site-specific criteria. If the proposed sampling detects exceedances of the site-specific criteria at the approved sampling locations, additional sampling should continue until the extent of the soil-gas in the utilities is delineated and all connected receptors evaluated. This should be conducted anywhere necessary, both on-site and off-site.
- In the event of site-specific criteria exceedance entering a building or directly adjacent to a building, measures to protect receptors should be implemented immediately to mitigate any potential risks to the inhabitants of the structures.

It is expected that Ford and their contractors will implement this work on an expedited basis and complete the work within the calendar year. If you have any questions, concerns, or would like to meet with EGLE to discuss, please contact me at algerb@michigan.gov or 586-623-2839.
