The Michigan Department of Environment, Great Lakes, and Energy (EGLE) Remediation and Redevelopment Division (RRD) has reviewed the draft Off-Site Utility Corridor Remedial Investigation Report submitted by Arcadis of Michigan, LLC on behalf of Ford Motor Company (Ford) on November 7, 2025, in accordance with Section 6.7(b) of the Consent Decree (CD) entered by EGLE and Ford on July 27, 2017.

Pursuant to Section 13.2 of the CD, EGLE approves the submission. Upon a notice of approval from EGLE, Ford shall submit a new cover page and mark the submittal as "Approved". It is recommended that Ford submits the final "Approved" submittal, via the Remediation Information Data Exchange (RIDE) web-based application located at the State of Michigan – EGLE website: <https://www.michigan.gov/egle/maps-data/ride>.

Please note that the Remedial Action Plan for the Off-Site Utility Corridor Area of Concern is due within 60 days of Ford receiving EGLE approval of the Remedial Investigation Report as defined in Paragraph 6.8 of the CD.
